# Scholarship Guidelines

## Jefferson County Parks and Recreation

- Proof of County residency may be required.
- Proof of annual or monthly income may be required.
- Each application will be thoroughly evaluated and based solely on financial need.
- If approved the individual or family (if family request) will receive from 80% to 10% of the program or entry fee cost up to \$50.00. It will be the applicant's responsibility to make up the additional payment in order to attend the requested program.
- There is a limit of one scholarship per individual per calendar quarter. Quarters are as follows: January - March, April - June, July - September, October-December. A new scholarship application will have to be submitted each quarter in order to receive benefit for that quarter.
- Scholarships are limited to individuals only. Groups and organizations are not eligible to apply.
- Scholarship applicants will be notified by letter outlining the scholarship amount and usage requirements or in person.
- The financial requirements are based on the financial aid guidelines in Schedule A.
- No more than 20% of the program can be given away to scholarship participants.
