Disabled Veteran Campground Fee Policy

Disabled Veteran Lifetime Pass - No Charge

Free camping. Valid year-round during normal camping season. Offered to Washington state residents with a documented service-connected disability of at least 30 percent.

Acceptable Proof of Eligibility

You may be required to provide the following to verify your status:

For Residency

Washington state driver's license; disabled person parking placard; voter registration card; property tax exemption statement. (Must be Washington resident for the past 12 consecutive months)
Applicant cannot claim multiple state residencies.

For Age

Washington state driver's license or ID card; copy of birth certificate; notarized affidavit of age; witnessed statement of age.

Proof of Disabled Veteran Status

A disability award letter, certification from the Department of Veterans Affairs or military service; a separation certificate or similar document on official letterhead stationery from the certifying agency, or have the pass application signed by the Department of Veterans Affairs or military service.

A State Parks Disabled Veteran Lifetime Pass

Your Washington State Parks disabled veteran lifetime pass can be used to verify your status for a Jefferson County Parks and Recreation Pass. This pass is credit card sized and made of hard white plastic.

Administrative Fee

A fee of \$15 will be charged for replacement of lost, stolen or damaged permits or passes.

Administration

An application form will be provided. Completed applications will be reviewed by the Division Manager within two weeks of receiving the application. The pass does not cover previous camping fees (you must have your pass to receive free camping). A laminated pass will be provided.

Rules for Pass Holders

1. Pass must be current and with you at all times.
2. Pass holder must be camping at the site.
3. Guests of pass holder camping at a separate site must pay the full regular fee.
4. Campers are limited to a 7 day stay in one park.
5. Pass does not provide discounts on other services such as shelter rental.
6. Passes are valid only at Jefferson County Parks
7. They are not accepted at campgrounds operated by other government agencies or private businesses.
8. A pass cannot be used in conjunction with any other pass or discount.
9. Pass only valid for person issued.
